[ON-SCREEN HEADLINE: ICE Shooter: 'I Want to Cause Terror']

ACTING U.S. ATTORNEY FOR THE NORTHERN DISTRICT OF TEXAS NANCY LARSON: The Dallas ICE facility was riddled with gunfire.

MAURICE DUBOIS: The FBI says the deadly shooting at a Dallas ICE office was a long-planned work of one man with one goal.

FBI SPECIAL AGENT IN CHARGE JOE ROTHROCK: Jahn specifically intended to kill ICE agents.

[ON-SCREEN HEADLINE: ICE Office Shooting]

DUBOIS: In the many shootings with multiple victims this country has seen over the years, motive is often not clear. But in the deadly shooting yesterday at an ICE facility in Dallas, the FBI says the gunman left handwritten notes that provide clues. The bureau says the gunman hated the federal government and wanted to terrorize and kill ICE agents. No agents were shot in the attack, but three immigrant detainees were. One died. The two others are in critical condition. Omar Villafranca is in Dallas once again tonight. Omar?

OMAR VILLAFRANCA: Investigators found a ladder they say the suspect used to get to the top of a building, and that's where they say that he used a legally purchased rifle and started shooting, and we are also learning chilling details of how he felt about ICE agents.

[ON-SCREEN HEADLINE: ICE Office Shooting; U.S. Attorney: Gunman Wanted to 'Terrorize' ICE Agents]

ROTHROCK: Jahn specifically intended to kill ICE agents. He fired at transport vehicles carrying ICE personnel, federal agents, and detainees.

VILLAFRANCA: The FBI says 29-year-old Joshua Jahn mapped out Wednesday morning's ambush on a Dallas ICE facility with a high degree of pre-attack planning, from internet searches of Dallas County DHS buildings to ballistics and apps that track the presence of ICE agents. Denise Robleto was bringing her mother to a scheduled ICE appointment when she heard gunshots. Robleto said she didn't know if ICE agents were shooting or being shot at. Nancy

Larson is the U.S. Attorney for the Northern District of Texas.

LARSON: He called the ICE employees “people showing up to collect a dirty paycheck.” He wrote that he intended to maximize lethality against ICE personnel and to maximize property damage at the facility.

VILLAFRANCA: Investigators say they uncovered a trove of new evidence from electronic devices found in a search of homes in Texas and Oklahoma associated with the suspect. The FBI says the clearest motivation can be found in Jahn’s own notes. FBI Special Agent in Charge Joseph Rothrock.

ROTHROCK: In his handwritten notes, he says I want to cause terror. He wants to impact ICE agents and law enforcement across the country.

VILLAFRANCA: At the ICE facility in Dallas, immigrants come into the building for scheduled ICE check-ins told CBS News they were told the building is closed and to come back Monday. Todd Lyons is acting director of U.S. Immigration and Customs Enforcement.

ACTING ICE DIRECTOR TODD LYONS: We won’t be stopped by it. We are going to do our law enforcement mission, right? We’re going to ensure that we are out there taking these public safety threats off the street.

VILLAFRANCA: DHS officials say that, during the shooting, ICE agents actually manage to move a few of the detainees who were constrained in that van out of harm’s way. We were also pressing DHS officials on what they plan to do to secure facilities like the one behind me. They didn’t want to go into detail, but they said plans are being discussed.

DUBOIS: Omar Villafranca in Dallas tonight, thank you.
