[ON-SCREEN HEADLINE: Breaking Overnight; Another ICE-Involved Shooting in Minneapolis]

NATE BURLESON: But we begin in Minnesota where there's another shooting involving ICE. This time, the man was shot in the leg. The shooting prompted a new round of protests last night and federal agents once again used controversial tactics against the demonstrators. Lana Zak joins us from Minneapolis. Lana, good morning. So, what do we know about this shooting?

LANA ZAK: Well, honestly, there's a lot we still don't know, but federal officials say a migrant was shot in the leg after attacking an agent with a shovel. We have yet to confirm that story, but it's just the latest in a city that is still reeling just about a week after the shooting of Renee Good. I spoke with her attorney about what comes next. [SHOUTING] Overnight, federal agents and protesters facing off again after an ICE officer shot a Venezuelan migrant in the leg. According to DHS, the officer acted in self-defense following an attack by the man and two other people using a snow shovel and broom.

FREY: This is an impossible situation that our city is presently being put in.

ZAK: Earlier, Governor Tim Walz had urged Minnesotans to protest peacefully and document

what he called ICE agent's atrocities.

MINNESOTA GOVERNOR TIM WALZ (D): They are pulling over people indiscriminately, including U.S. citizens. [SCREAMING] They're breaking windows, dragging pregnant women down the street. This long ago stopped being a matter of immigration enforcement.

ZAK: This is the second person shot by ICE agents in a week.

RENEE GOOD [on 01/07/26]: That's fine, dude. I'm not mad at you.

[ON-SCREEN HEADLINE: Breaking Overnight; Protesters Continue Clashing With ICE in MN]

ANTONIO ROMANUCCI: The mission that we've been told about for over a year is that it's to get the worst of the worst. I can tell you that Renee was the best of the best.

ZAK: We spoke to Renee Good's family attorney, Antonio Romanucci. [TO ROMANUCCI] Did Renee weaponize her car?

ROMANUCCI: Looking at the video, the way — the speed of the car, the direction it was turned and what she said to those officers beforehand, the totality of the circumstances would indicate that she did not weaponize her car.

ZAK: On, Tuesday six federal prosecutors stepped down amid pressure, sources say, to treat Good's killing as an assault on the ICE officer. Now, the family is pursuing its own separate investigation.

ROMANUCCI: The thought that there is only a one-sided investigation is really not palatable to the family nor should it be to the government or the American people.

ZAK: And, as for Jonathan Ross, the agent who shot and killed Renee Good, the DHS has said he was also acting in self-defense. They said yesterday that he suffered internal bleeding. We still don't know the extent really of those injuries and, from the video, it is not clear whether or not the car made contact with him and — and how forceful it may have been. The attorney — the Deputy Attorney General Todd Blanche is accusing now Minnesota authorities of stoking violence here. It is an assertion that they reject, and you heard the governor say yesterday that people need to document what he is calling the atrocities against Minnesotans. I'll send it back to you.

KING: Alright, Lana, thank you. We'll take it.
