**MOTION TO STRIKE RESPONSE TO**  
**NOTICE OF SUPPLEMENTAL AUTHORITY**

Appellants, Zachary Young and Nemex Enterprises, Inc., by and through undersigned counsel, and pursuant to Florida Rules of Appellate Procedure 9.225 and 9.300, move to strike the Response to Notice of Supplemental Authority filed by Appellee, The Associated Press, on June 12, 2026, and as grounds therefor state:

1. On June 11, 2026, Appellants filed a Notice of Supplemental Authority (the "Notice") in compliance with Florida Rule of Appellate Procedure 9.225, citing and attaching *Perlmutter v. Federal Insurance Company*, Case No. SC2024-0058 (Fla. June 11,

2026).

2. The following day, on June 12, 2026, Appellee filed its Response to Notice of Supplemental Authority (the “Response”).

3. The Response is unauthorized by Rule 9.225, which governs the provision of supplemental authority to the Court following the conclusion of briefing.

4. Further, the Response impermissibly contains argument regarding the authority cited in Appellants’ Notice. Fla. R. App. P. 9.225 (“The notice shall not contain argument....”).

5. Because the Response is unauthorized by Rule 9.225 and impermissibly contains argument, Appellants respectfully request that this Court strike the Response from the docket and disregard its contents.

WHEREFORE, Appellants, Zachary Young and Nemex Enterprises, Inc., respectfully request that this Court enter an order striking Appellee’s Response to Notice of Supplemental Authority from the docket, disregarding its contents, and granting any other and further relief that this Court deems just and proper.
