NOTICE OF ORAL ARGUMENT

attorney represents and, if entitled, how much of the allotted time the attorney would like to reserve for rebuttal. If the attorney or a party has a unique name, please include a phonetic pronunciation of the name.

In cases where Article I, section 16 of the Florida Constitution applies, if the victim—as defined in that provision—has requested notice of this oral argument, the State of Florida is directed to provide such notice.

NOTICE OF REQUIREMENTS FOR CONTINUANCE

Motions for continuance will be granted only for good cause, when requested in a timely manner. A motion for continuance filed more than 10 days from the date of this notice will be considered only upon a showing of emergency or unforeseen circumstances.

Motions for continuance must state the grounds upon which they are based, that movant's counsel has consulted with opposing counsel, whether movant's counsel is authorized to represent all parties' positions on the motion, and, if authorized, those positions.
